We found the January 26th news release titled, "*Antimony Resources Corp. (ATMY) (ATMYF) (K8J0) Reports More Massive Antimony-Bearing Stibnite ("Sb") of 5.10% Sb over 4.0 meters, 2.15% Sb over 6.85 meters and 2.38% Sb over 9.60 meters*" particularly noteworthy and here are 5 key data points from it:

- **High-Grade Antimony Intersections** – Antimony Resources Corp. reported multiple strong stibnite intercepts at the Bald Hill Antimony Project, including 5.10% Sb over 4.0 m, 2.15% Sb over 6.85 m, and 2.38% Sb over 9.60 m, with local core sections grading up to 30% Sb.
- **Consistent Mineralization Across Drilling** – Antimony mineralization was encountered in 75–80% of drill holes, with five of nine holes containing massive stibnite zones, indicating strong continuity.
- **Large, Expanding Main Zone** – The Main Zone has been extended to over 700 m strike length and at least 400 m depth, with average widths of 3–4 m and grades around 3–4% Sb.
- **Substantial 2025 Drill Program** – The Company completed over 8,000 m of drilling in 31 holes during 2025, with remaining Phase Two holes planned to continue in the 2026 program.
- **Exploration Target Potential** – A 2025 technical report outlines a conceptual target of ~2.7 Mt grading 3–4% Sb (80,000–106,000 tonnes contained antimony), highlighting

potential for a significant North American antimony deposit pending further work.
