Here are 5 key data points from their April 17<sup>th</sup> news release titled, *“Rockland Expands Critical Minerals Position with New Beryllium and Tungsten Claims at Meteor Project in Utah”*:

- **New Acquisition:** Rockland Resources Ltd. has acquired the Meteor Beryllium and Tungsten Project in Juab County, Utah, comprising 28 unpatented mining claims covering 525.2 acres, including several historical mines such as East Apex, Hornet, and East Trout Creek.
- **Historical Production and Grades:** The East Apex Mine reported historical beryllium grades up to 2.42% BeO, while the Hornet Mine previously produced 60 tons of tungsten ore averaging 2.0% WO<sub>3</sub>. Other prospects also showed beryllium and tungsten mineralization.
- **Strategic Importance:** The project enhances Rockland’s beryllium portfolio and adds tungsten at a time when China controls 83% of global tungsten supply and has restricted exports to the U.S. since February 2025.
- **Alignment with U.S. Policy:** The acquisition aligns with President Trump’s executive order to strengthen U.S. critical mineral supply chains, particularly for defense and industrial applications.
- **Exploration Plans:** Rockland plans a field program involving geological mapping, geochemical sampling, ground geophysics, and permitting for drill testing through the

Bureau of Land Management.
