We found the July 18<sup>th</sup> news release titled, *SRC Announces 2024 Exploration on Ballarat Gold Project, Yukon*, particularly noteworthy, and here 5 key data points from it:

1. **Significant Land Position in Yukon:** Stakeholder's Ballarat Gold Project covers an expansive 18,741 hectares in the

**White Gold District**, a key area for mineral exploration in Yukon Territory, Canada. The project lies near major mining initiatives like Newmont's Coffee Gold Project and Western Copper's Casino Project.

2. **Extensive Exploration Program for 2024:** The upcoming exploration will include high-resolution soil sampling, ground-based VLF surveys, geological mapping, prospecting, and a drone magnetic survey. These methods aim to provide detailed insights into the geology of the Skye and Loki zones, with a focus on understanding structural controls and mineralization.
3. **Skye Zone Gold Anomalies:** The gold-in-soil anomalies in the Skye Zone are notable for being up to 1.9 km long and showing only slightly elevated levels of lead and molybdenum, suggesting a unique geochemical signature. The anomalies are believed to be structurally controlled, with similarities to known deposits in the region.
4. **Loki Zone Copper Discovery:** The copper anomaly at the Loki Zone is tied to a Jurassic-aged intrusive unit, with surface dimensions of approximately 1,000 m by 300 m. This area could offer insight into larger copper mineralization, supported by the results of ridge and spur sampling.
5. **Proximity to Infrastructure:** Both the Skye and Loki zones are located close to the proposed Northern Gateway Road, which runs for more than 17 km through the company's claims. This proximity could provide significant logistical benefits for ongoing exploration and potential future development.
