Stakeholder Gold holds a 100% interest in 930 contiguous mineral claims covering 18,520 hectares along roughly 20 km of the proposed Northern Gateway Road in the White Gold District of Yukon, Canada. The Company also maintains 10 claims within the adjacent Coffee Mine Project operated by Fuerte Metals Corp.; together these properties form the Ballarat Gold-Copper Project. Exploration is focused on the Skye Gold Zone and the Loki Copper Zone, located about 8 km apart on either side of the proposed road and prospective for new gold and copper discoveries. In addition to exploration activities, Stakeholder generates cash flow through its wholly owned Brazilian subsidiary Mineração VMC Ltda., which operates four stone quarries and exports exotic stone building materials.

We found the January 20<sup>th</sup> news release titled, “*Stakeholder Receives Class 1 Exploration Approval for Ballarat*” particularly noteworthy and here are 5 key data points from it:

- **Exploration Permit Granted** – Stakeholder Gold Corp. received a Class 1 Exploration Notification approval from the Yukon Government, allowing exploration and drilling at the Ballarat Gold-Copper Project.
- **2026 Drill Program Planned** – The approval enables early-season 2026 drilling of priority targets at the Skye Gold Zone and Loki Copper Zone, located approximately 8 km apart.
- **Strategic Infrastructure Location** – The Ballarat project lies in the White Gold District along the proposed Northern Gateway Road, providing favorable access and development logistics.
- **Large Land Package** – The Company controls 930 contiguous claims (~19,440 hectares) plus 10 additional claims within the adjacent Coffee Mine Project, forming a substantial exploration footprint.
- **Additional Revenue Source** – Beyond exploration, the Company generates cash flow through its Brazilian subsidiary operating four exotic stone quarries, supporting project funding diversification.
