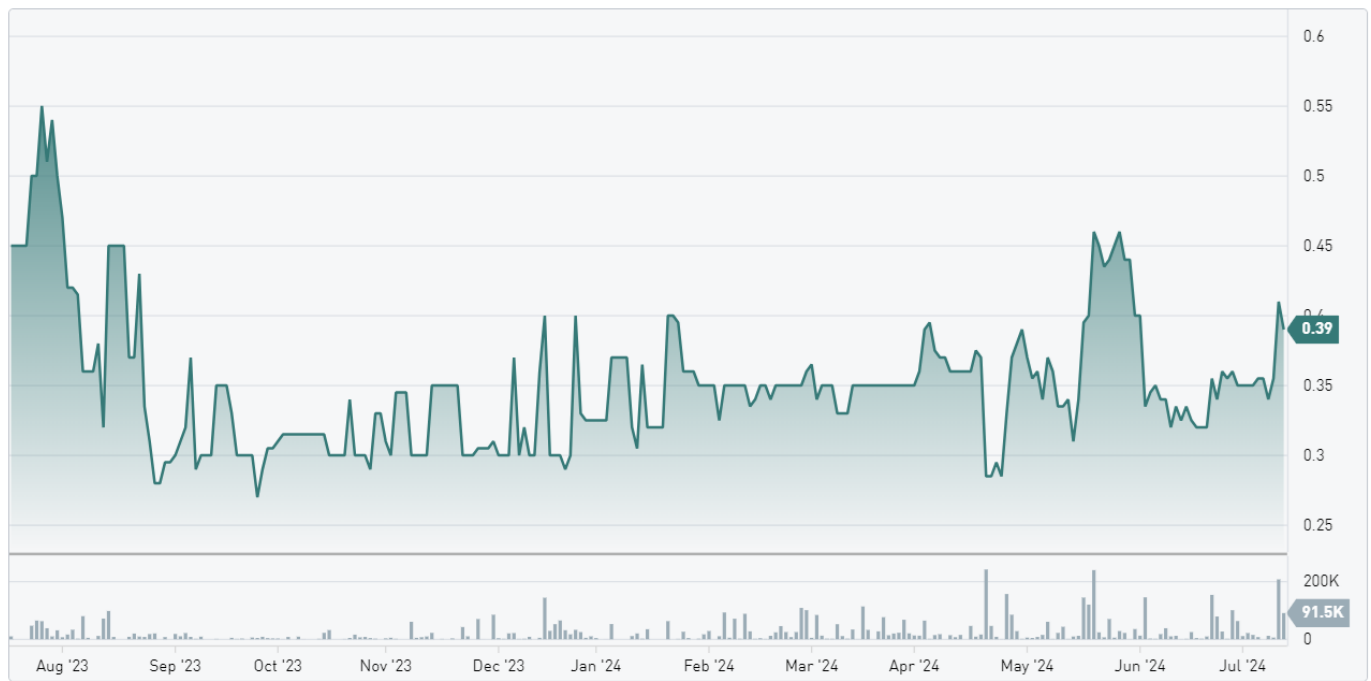

1. **Significant Gold Intersections Reported:** Notable intersections include 9.0 meters at 23.89 g/t Au, with a highlight of 1.0 meter at 210.00 g/t Au.
2. **Completion of Diamond Drill Program:** The initial drill program concluded with 25 holes totaling 4,368 meters across three targeted zones.
3. **Diamond Drill Hole Highlights:** Key results: 15.1 meters at 1.03 g/t Au and 11 meters at 1.71 g/t Au among others.
4. **Future Exploration Plans:** Q3 drilling phase will target Jagger, Road Cut, and Kadie Zones, with 2024 plans aiming for 10,000 to 12,000 meters.
5. **Funding and Strategic Position:** A successful private placement raised \$7.4 million, ensuring strong financial backing for future exploration.
