Romios Gold Resources Inc. is a mineral exploration company focused on gold, copper, and silver discoveries. Its flagship Trek South project in British Columbia's Golden Triangle has shown strong geophysical and geochemical results from mapping, sampling, and IP-MT surveys, indicating high discovery potential. A drill permit is in place, with an updated NI 43-101 and first drilling planned for 2026. Romios also holds 100% interests in the Kinkaid (Au-Ag-Cu) and Scossa (high-grade Au) projects in Nevada, and the Lundmark-Akow Lake Au-Cu property near Musselwhite Mine in Ontario. Additional assets include 2% NSR royalties on McEwen Mining's Hislop gold property and Enduro Metals' Newmont Lake project in British Columbia.

We found the October 21st news release titled, "*Romios Begins New Round of Fieldwork on the Kinkaid Copper-Gold-Silver Project, Walker Lane Trend, Nevada*" particularly noteworthy and here are 5 key data points from it:

- **New Field Program Initiated:** Romios has launched a 10-day geological mapping and sampling program at its 100%-owned Kinkaid Copper-Gold-Silver Project in Nevada's Walker Lane trend. The program aims to advance the PM Skarn and Bismark Hill targets toward drill-ready status.
- **Bismark Hill High-Grade Results:** Sampling from the 350 x 240 metre alteration zone at Bismark Hill returned up to 36.3 g/t gold and 4.8% copper from quartz veins, as well as additional assays of 13.95 g/t and 6.09 g/t gold from altered zones—indicating strong potential for a broad gold-copper mineralized system.
- **Exceptional Silver and Gold Grades at PM Skarn:** Historical and recent sampling at PM Skarn includes assays of 1,725 g/t (61 oz/t) silver, 6.9% zinc, 0.4% copper, and 1% lead from quartz veins, along with 10.6 g/t and 3.2 g/t gold in associated quartzite and skarn zones—typical of epithermal

gold systems.

- **Potential Porphyry Cu-Au System:** Geological evidence suggests both Bismark Hill and PM Skarn may overlie as many as five buried porphyry copper-gold intrusive centers, representing a significant new exploration model for the Kinkaid Project.
- **Broader Exploration and 2026 Plans:** Romios plans to follow up this fieldwork with an induced polarization (IP) survey in 2026, while also advancing its Trek South Cu-Au prospect in British Columbia (adjacent to Teck-Newmont's Galore Creek project) toward first-ever drilling next field season under an existing drill permit and upcoming NI 43-101 report.
