

Melissa “Mel” Sanderson to Champion Critical Minerals Sustainability at Future Minerals Forum 2026

TORONTO, ONTARIO – January 6, 2026 – [Melissa “Mel” Sanderson](#), Co-Chair of the [Critical Minerals Institute](#) (CMI), will be a featured panelist at the [Future Minerals Forum \(FMF\) 2026](#), taking place January 13–15, 2026, in Riyadh, Saudi Arabia. Sanderson will participate in high-level discussions with global policymakers, investors, and industry leaders on strategies to secure critical mineral supply chains and drive sustainable development.

Sanderson is slated to speak on January 15th on the panel **“Increase funding and focus on rare earth mineral exploration,”** where she will address critical mineral supply gaps, investment approaches, and national security implications for the United States. In her own words: “I’m going to address the implications for the United States of being so far behind in this rush to secure these resources, and what that means for both U.S. national security and economic development.”

She also emphasized the value of this forum’s format, noting: “Unlike many other events, it’s one that connects the private sector directly with the policymakers that are determining future investments in the companies trying to develop resources in those countries in a responsible way.”

She currently serves on the boards of American Rare Earths Limited (ASX: ARR | OTCQX: ARRNF | ADR: AMRRY), a critical minerals developer advancing rare earth supply projects in the United States, and [CVMR Corporation](#) (CVMR Inc.), a diversified technology metals producer focused on rare earths and related materials.

Sanderson also serves as Professor of Practice at the Thunderbird School of Global Management (Arizona State University) and is a contributing [columnist](#) for InvestorNews.
