## Sage Gold Announces Closing of the First Tranche of Private Placement

January 15, 2018 (<u>Source</u>) - <u>Sage Gold Inc.</u> ("<u>Sage Gold" or the</u> "<u>Company"</u>) (TSX VENTURE:SGX) is pleased to announce that further to its news release dated January 5, 2018, it has completed the first tranche of a treasury offering (the

"Offering") of units of the Company (the "Units") at the price \$0.11 per Unit. Each Unit consists of one common share of the Company (a "Common Share") and one (1) Common Share purchase warrant (a "Warrant"). Each Warrant entitles its holder to purchase one Common Share at an exercise price of \$0.16 for a period of 24 months following the closing of the Offering. The first tranche of the Offering (the "First Tranche") consisted of the sale of 6,397,226 Units for gross proceeds of \$703,694.96.

In connection with the closing of the First Tranche, finders' fees of \$19,400 were paid and 110,225 compensation warrants ("Finders' Warrants") were issued to certain eligible finders. Each Finder Warrant entitles the holder to acquire one Common Share at the exercise price of \$0.16 per Common Share for 24 months following the closing of the First Tranche.

Securities issued pursuant to the First Tranche are subject to a four-month plus one day hold period commencing on the day of the closing of the First Tranche under applicable Canadian securities laws. The Offering is subject to final acceptance of the TSX Venture Exchange. Following the completion of the First

Tranche, 92,629,383 Common Shares will be issued and outstanding. The Company intends to use the net proceeds from the Offering for mine development and general working capital purposes.
