

# Troilus Announces AGM Results

(TSX: TLG; OTCQB: CHXMF) (“Troilus” or the “Company”), reports, in accordance with the policies of the Toronto Stock Exchange, that the nominees listed in the Management Information Circular dated November 1, 2022 for the Annual General Meeting of Shareholders of the Company (the “Meeting”) were elected as directors of the Company. Over 52% of all of the issued and outstanding shares of the Company were represented at the Meeting.

Detailed results of the vote for the election of directors held at the Meeting on December 8, 2022 in Toronto, Ontario are set out below.
