Each tonne of ammonia generated prevents up to two tonnes of CO₂e emissions, delivering both economic and environmental benefits. Built for simplicity, reliability, and remote operation, the containerized systems integrate easily into existing farm infrastructure and are engineered for Canadian conditions. The FP300 demonstration system, installed on an 11,000-acre farm in Sperling, Manitoba, produces 100 metric tonnes of Green Ammonia annually and serves as the foundation for the FP1500 commercial model, capable of 500 tonnes per year. Supported by Stantec, FuelPositive aims to establish Canada as a global hub for decentralized Green Ammonia production, driving sustainable agriculture, economic growth, and high-value employment in engineering, science, and skilled trades.

- **National Manufacturing and Economic Vision:** Supported by Stantec, FuelPositive aims to position Canada as a global centre of excellence for decentralized Green Ammonia production, driving innovation, job creation, and sustainable agricultural growth.
