We found the March 10th news release titled, “*Visionstate Provides Strategic, Technology Update, Including New Ai Model*” particularly noteworthy and here are 5 key data points from it:

- **Standalone Inspections Application Launch:** Visionstate plans to launch a new inspections application in early Q3 of the current fiscal year, providing a digitized, end-to-end solution for assessing and auditing cleaning quality. This product will integrate with WANDA and create a new revenue stream.
- **AI Model Development with Amii:** Visionstate is collaborating with the Alberta Machine Intelligence Institute (Amii) on an AI model to optimize cleaning schedules and routing, targeting a completion date in Q4 2025. This innovation is slated to become a standalone product and additional revenue stream.
- **Turing Award Recognition:** Richard Sutton, an Amii scientific advisor, has been honored with the 2024 A.M. Turing Award, highlighting the prestige and expertise that supports Visionstate’s AI initiative in reinforcement learning.
- **Compliance with Ontario Legislation:** Updated WANDA software will address Ontario’s new O. Reg. 480/24 legislation, which requires washroom cleaning activities to be recorded and posted for workers, taking effect January 1, 2026.
- **Market Opportunity and Timelines:** Visionstate intends to

onboard customers affected by Ontario's upcoming regulations in Q3 and Q4, positioning the company to capture this new market segment well before the January 1, 2026, implementation deadline.
