METEORIC RESOURCES NL (ASX:MEI) – 2024 SHARE PURCHASE PLAN NOW OPEN

On behalf of the Board of Meteoric Resources NL (ASX:MEI) (**Meteoric** or **Company**), I invite Eligible Shareholders to participate in the Meteoric share purchase plan (**SPP**) as first announced to the ASX on 26 July 2024.

Eligible Shareholders are Company shareholders with a registered address in Australia who were registered holders of Shares at **5.00pm (WST) on 25 July 2024**.

Under the SPP, Eligible Shareholders have an opportunity to purchase between A\$500 and A\$30,000 worth of ordinary shares in the capital of the Company (**Shares**), irrespective of the size of their shareholding, without incurring brokerage or transaction costs (**Offer**).

Meteoric is seeking to raise approximately A\$5 million under the SPP through the issue of approximately 45,454,546 Shares at an issue price of A\$0.11 per Share, the same price at which Shares were issued under the Placement announced to ASX on 26 July 2024 (**Placement**).

The SPP Share issue price represents a 16.83% discount to the 15-day VWAP Share price up to 26 July 2024, the last trading day before the Placement and SPP were announced to ASX, and a discount of 8.33% to the closing Share price on 23 July 2024 of A\$0.11.

Proceeds raised under the SPP will be used to accelerate development of the Caldeira Project including the completion of a PFS, commissioning of a demonstration plant and progression of key license and approvals.

The Offer is being made on the terms and conditions set out in the Offer Booklet dated 5 August 2024 lodged with ASIC on that date and which is available on the Company's website at <https://meteoric.com.au/>. Further details regarding the SPP have also been announced to the ASX and are available on ASX's website.

Invitation to Participate in Meteoric Resources NL's Share Purchase Plan

Introduction

Meteoric Resources NL (ACN 107 985 651) (**Meteoric** or the **Company**) invites eligible shareholders to participate in a share purchase plan (**SPP**), to subscribe for ordinary fully paid shares (**New Shares**) in the Company on the terms and conditions enclosed with this letter to acquire New Shares at a price of \$0.11 per New Share (**Offer**).

The amount proposed to be raised under the SPP is \$5,000,000 representing approximately 45,454,546 New Shares (subject to rounding). The Directors, however, reserve the absolute discretion to determine the final amount raised under the SPP and may accept over subscriptions or scale back any application at the Directors' absolute discretion on any basis they deem fit, subject to compliance with the ASX Listing Rules (including that the number of New Shares issued under the SPP does not exceed 30% of the number of Meteoric Shares currently on issue) and *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*.

The SPP is being conducted as part of a wider fundraising exercise that includes funds that were raised on 26 July 2024 by way of a placement to certain investors (including sophisticated and professional investors) (**Placement**) of 250,000,000 New Shares at a placement price of \$0.11 per New Share to raise \$27.5 million (before costs).

FREQUENTLY ASKED QUESTIONS

1) What is the SPP?

The SPP provides each eligible shareholder with an opportunity to subscribe for New Shares (subject to any scale back at the Board's absolute discretion), without paying any brokerage fees, commissions or other transaction costs, at the issue price of \$0.11 per Share (**Issue Price**) for a total application price not exceeding \$30,000.

The amount proposed to be raised under the SPP is \$5,000,000 representing approximately 45,454,546 New Shares (subject to rounding). The Directors, however, reserve the absolute discretion to determine the final amount raised under the SPP and may accept over subscriptions or scale back any application at the Directors' absolute discretion on any basis they deem fit, subject to compliance with the ASX Listing Rules (including that the number of New Shares issued under the SPP does not exceed 30% of the number of Meteoric Shares currently on issue) and *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*.

The volume weighted average market price of the New Shares on the Australian Securities Exchange (**ASX**) during the 5 trading days immediately prior to the announcement date of the Offer was \$0.132 per Share. The Issue Price under the SPP (being \$0.11 per New Share) is a 16.83% discount to the above volume weighted average price. 6) How will custodians, trustees and nominees be treated under the SPP?

- is exempt from holding an Australian financial services licence with a specific custodian or depository authorisation or by relying on the Australian financial services licence of your master custodian under regulation 7.1.06(k) of the *Corporations Regulations 2001* (Cth);
- is a trustee of a self-managed superannuation fund;
- is a trustee of superannuation master trusts;
- is a responsible entity of IDPS-like schemes; or
- is noted on the Company's register of members as holding the shares on account of another person.

If you hold Meteoric Shares as a trustee or nominee for another person or persons but are not a Custodian as defined above, you cannot participate for beneficiaries in the manner described above. In this case, the rules for multiple single holdings (above) apply.

Price of New Shares

The Issue Price is \$0.11 per New Share, being a 16.83% discount to the volume weighted average price of the New Shares on the Australian Securities Exchange (**ASX**) during the 5 trading days immediately prior to the date of the announcement of the Offer.

Shareholders considering subscribing for New Shares under the SPP should be aware of the risk that the market price may change between the date of this Offer and the date that the New Shares under the SPP are issued.

By accepting the Offer and applying for subscription of New Shares under the SPP, each Eligible Shareholder will be acknowledging that New Shares are a speculative investment and the price of New Shares on ASX may change between the date of the Company announcing its intention to make an Offer and the date of issue of New Shares under that Offer and that the value of the New Shares received under the SPP may rise or fall accordingly.

Applications, notices and certification

At the Board's discretion, the Company will send Eligible Shareholders a letter of offer and acceptance procedures, inviting them to subscribe for New Shares under the SPP, and accompanied by the Terms and Conditions of the SPP and an Entitlement & Acceptance Form. - (a) acknowledges that the application is irrevocable;
- (b) acknowledges and warrants they are an Eligible Shareholder; and

- (c) certifies that the aggregate of the application price for the following does not exceed \$30,000:
- (i) the New Shares that are the subject of the application; and
 - (ii) any other New Shares applied for by the applicant under the SPP (or any similar arrangement in the 12 months prior to the application), whether:
 - (A) in the applicant's own right; or
 - (B) jointly with one or more persons; or

No cooling off rights

No Underwriting

The Offer will not be underwritten.

Issue of New Shares

New Shares to be issued under the SPP will be issued as soon as reasonably practicable and no later than 10 business days after the Closing Date.

New Shares issued under the SPP will rank equally in all respects with all other fully paid ordinary shares in the Company from the date of issue.

Holding statements or CHESS notification will be issued in respect of all New Shares issued under the SPP. The Company will, promptly after the issue of New Shares under the SPP, make application for those New Shares to be listed for quotation on the Official List of ASX.

Modification and termination of the SPP

The Company may modify or terminate the SPP at any time. The Company will notify ASX of any modification to, or termination of, the SPP. The omission to give notice of any modification to, or termination of, the SPP or the failure of ASX to receive such notice will not invalidate the modification or termination.

Without limiting the above, the Company may issue to any Eligible Shareholder fewer New Shares than the Eligible Shareholder applied for under the SPP if the issue of the New Shares applied for would contravene any applicable law or the Listing Rules of ASX.

Dispute resolution

The Company may, in any manner it thinks fit, settle any difficulties, anomalies or disputes which may arise in connection with or by reason of the operation of the SPP, whether generally or in relation to any participant, application or New Shares. The Company's decision in this respect will be conclusive and binding on all shareholders and other persons to whom that determination relates.

The Company reserves the right to waive strict compliance with any provision of these Terms and Conditions. The Company's powers under these Terms and Conditions may be exercised by the directors of the Company or any delegate of the directors of the Company.
